1	The total number of sections of the school shall be restricted to 12 (one section in each class). Further increase of sections shall be subject to specific approval of the Board on the basis of the request of the school as per affiliation by elaw subject to availability of class rooms of greater than 500 ft dimension.
2	The school is required to construct a proper paved path from the entrance to the ramp within 03 months and submit the compliance.
